Who can be against improved emergency medical services, although I am not sure how or if it is related to becoming part of the Cook tax district.


A number of things in the survey like light pollution, new and redevelopment tend to be zoning issues and can be grouped under visual character of the lake. These should be dealt with on a individual basis.





Comment Responses:

- 7a). While "off lake" housing for young families may be needed at some point in time, I doubt that it is necessary for some time. The way the economy is going I doubt many young families can afford off lake housing.
- 7b). Off lake housing for seniors would be an acceptable method for those who wish to stay close to the lake are able to do so. This might be in the form of Condominiums with access to the lake.
- 7c). It appears there is sufficient "off lake" recreation being planned. The questions would be what is the usage of such current recreation facilities.
- 7d). Dark Sky ordinance is something that is questionable at this time. With all the lights currently on the water's edge it would appear to be useless to implement. At question too is the constant target by thieves to vandalize some ones cabin/home. I currently have security cameras (as do others) in place and utilize lighting to make sure there is a risk for someone to steal.
- 7e). Lake water is important and should be protected from chemicals that are harmful. However, the county now has responsibility for septic systems and also designs for road run off. The entity for enforcement is therefore the county.
- 7f). The visual character of the lake is important, but by the same token there is land available to whom someone would want to buy and place a cabin/home on. Is there a subliminal sense here suggesting curtailing construction?
- 7g). Public sewer systems are costly here due to the rock structure. There are however several alternatives for good systems and the county now provides permits so they ought to know what is good for this area. We particularly have a unique systems which works just fine and Northeast Technical indicates that the portion that goes to the drain field is so pure it could go back to the lake—but we use the drain field anyway.
- 7h). New lake shore development- does that pertain to new residences or public use? New residence would be fine but public use seems to be a waste.
- Outdoor amplified music and announcements should have been separate questions since one necessarily go with the other. There are timeframes in place for amplified music which should be adhered to. Announcements of an emergency nature need more research.
- 7j). Boat motor exhaust systems which are above the limits in place ought to be fined.
- 8a). Storm water runoff for new development should be reasonable. Those who already have runoff which is not in compliance should update...but will those who have their place be pleased with the rule??
- 8b) Runoff retention for existing residences should be encouraged but in some places that will be costly. Will the township absorb some of those costs? Probably not...
- 8c). Encourage nature restoration of shoreline should be at the residence discretion. Some folks have made improvements to their shorelines which enhance the beauty of the lake.
- 8d). There are currently in place if one would seek out information on how to provide great treatment systems. The county who gives out permits should provided alternatives.
- Publicly owned undeveloped areas will be at the will of the legislature/DNR. Vote those in office who are in favor of good reasonable choices.
- 9a). Existing rules that are in place for housing unit density should be enforced. But then don't ask the question as to whether we ought to plan for additional housing in multiple units.
- 9b). There are rules in place now for set backs etc., why do we allow variances?

- There are some areas where native shore line restoration will not enhance the beauty of the lake.
- 9d). Without the requirement of all residence this is a dumb rule.
- 9e). This question is not a reasonable request since the adjacent property may be terrible.
- 10a). There is not need for a new trail between Cook & Tower. One can bike and/or snowmobile between the two now.
- 10b). There are several trails now where folks can walk/bike, but I don't see them used.
- 10c). There is now enough recreation at the town hall. I would ask that a record be kept of the usage of what is in place; I would guess that they are not used to the extent that they were thought.
- 10d). There are trails now that could be used and skating is available at the townhall...but again what is the usage?
- 11a). I would discourage off lake assisted living units at this time.
- 11b). There are facilities available for assisted living for the elderly.
